Ceasolder-AL (acrylic latex) Peelable Solder Mask

DESCRIPTION

Ceasolder-AL is a peelable, temporary acrylic latex mask designed to mask areas to prevent pick up of solder, when using a wave soldering machine in electronic assembly applications. It contains no offensive ammonia and hence is non-corrosive to copper, gold, silver or pre-soldered surfaces. In addition, stability problems are averted. When applied the product is pink and when cured it becomes translucent red.

APPLICATION

Apply Ceasolder-AL by brush coating, printing or through squeeze bottle.

Suggested coating thickness to allow for shrinkage should be 20 to 30 mils. If material begins to thicken, use DI water to reduce viscosity. Surface should be clean and dry before applying Ceasolder.

1Hr @ Ambient 30 mins. @ 65C 20 mins. @ 82C
